2. Tang Capital Partners, LP ("TCP") beneficially owns 639,395 shares, Tang Capital Partners International, LP ("TCPI") beneficially owns 871,923 shares, Tang Capital Partners III, Inc. ("TCP III") beneficially owns 639,390 shares, and Tang Capital Partners IV, Inc. ("TCP IV") beneficially owns 639,395 shares. Kevin Tang is the sole manager of Tang Capital Management, LLC, which is the general partner of TCP and TCPI. Kevin Tang is the sole director and Chief Executive Officer of TCP III and TCP IV, which are indirectly wholly owned by TCP. Mr. Tang has a pecuniary interest in the shares beneficially held by TCP, TCPI, TCP III and TCP IV.
3. These shares were purchased in multiple transactions at prices ranging from \$2.38 to \$2.48.
4. These shares were purchased in multiple transactions at prices ranging from \$2.35 to \$2.44.
